In my imagination, I can almost hear the celebratory blast! The sound of the Jewish *shofar* announced the arrival this past autumn of the complete Bible translated into San Blas Kuna. It is a language spoken by 57,000-plus speakers living in Panama, a country situated on the strip of land connecting North and South America. The event, celebrated by 3,200 Kuna at a large Panama City church, featured a 100-voice Kuna choir, five Kuna pastors expressing gratefulness to God for His Word, and 80 guests from five countries.

“There is a picture forever imprinted in my mind and on my heart,” said one of the visitors. “I watched as a young lad—maybe eight or 10 years old—opened a Bible and began to read it out loud. For the first time in his life, he held God’s Word in his hands and he could read it. He could understand it. It was in his own language.”



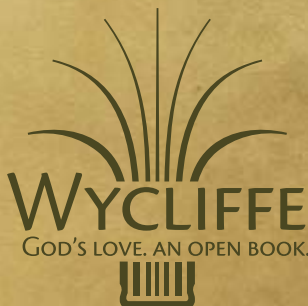

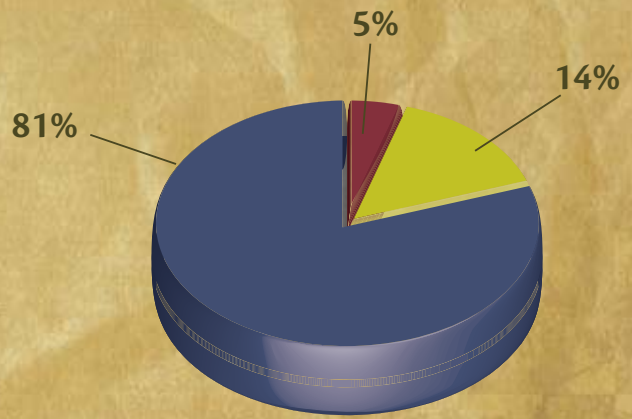
